DiplIFR Qualification

DiplIFR overview

The Diploma in International Financial Reporting is an internationally recognised qualification in financial accounting covering International Financial Reporting Standards (IFRS / IAS). It is developed by the ACCA (Association of Chartered Certified Accountants) and is aimed at accounting and finance professionals who already have experience in accounting, using local accounting standards.

Admission criteria

- Two years' relevant accounting experience and a relevant degree (attracting at least ACCA qualification exemptions for the Applied Knowledge and Corporate and Business Law (LW) exams)
- Two years' relevant accounting experience and an ACCA Certificate in International Financial Reporting
- Three years' relevant accounting experience
- ACCA affiliate status
- Member of an IFAC membership body (CECCAR, CAFR)

Exam dates and fees

The exam is held in June and December each year and can be passed with 50 marks out of 100. The exam is scheduled for **7 June 2024** and has a duration of 3hrs15min.

The initial registration deadline is 8 April 2024 (for the June 2024 exam session).

Once registered you have until 29 April 2024 to access the exam planner via your myACCA account and enter for the exam.

Initial registration fee – 89 GBP

Exam fee – 142 GBP

Registration documents

The following documents are needed for your DiplIFR application:

- **Proof of identification** – any of the following: driver's license, ID card, passport or birth certificate.
- **Copies of original documents and official English translations** of your Bachelor Degree and Diploma Supplement (if not in English), stamped by a licensed translator who is authorised and qualified to provide translation services
- **Work experience form** (if applicable)
